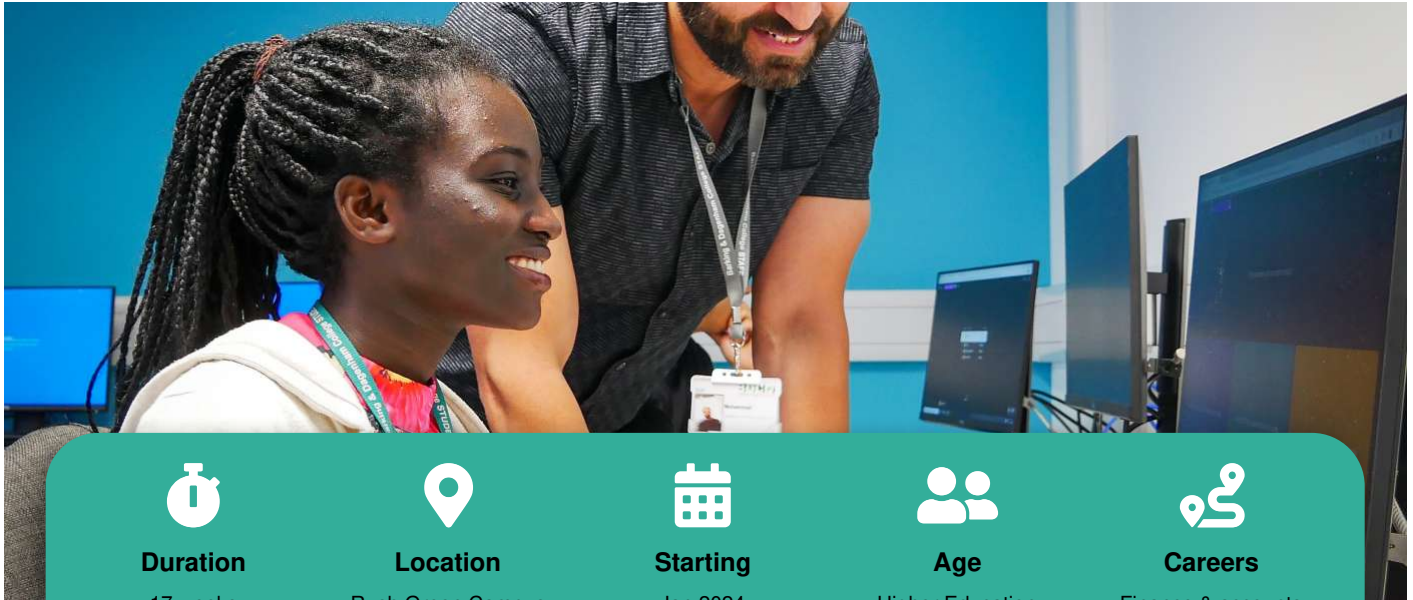

Overview

This qualification picks up where the foundation and advanced levels left off. It focuses on drafting, analysing and interpreting financial statements.

The overall learning aim of the unit is to equip you with a knowledge of taxation as it applies to UK taxpayers so that accurate and fair taxation liabilities can be computed. It also enables you to appreciate the theory behind taxation, including the ethical aspects as it specifically applies to a taxation practitioner.

This module can be studied in isolation to build you knowledge in this specific area, or studied alongside other AAT accredited modules, to lead to an AAT Professional Diploma in Accounting.

What you'll learn

This course will provide you with the fundamental knowledge of the three most common taxes that affect taxpayers in the United Kingdom (UK): income tax, capital gains tax and inheritance tax. With this knowledge, you will then understand the taxation implications of decisions made by clients and understand that advice and guidance may be offered to ensure that the taxpayer is complying with tax legislation.

By the end of this module you'll be able to:

- Understand principles and rules that underpin taxation systems
- Calculate UK taxpayers' total income
- Calculate income tax and National Insurance contributions (NICs) payable by UK taxpayers
- Calculate capital gains tax payable by UK taxpayers
- Understand the principles of inheritance tax

You'll need to have GCSE Grade 4 and above in both English Language and Mathematics, or equivalent and you will also need to have completed the AAT Advanced Diploma in Accounting at Level 3 to study on this programme.
